Subject: Free Pesticide Disposal Event 2026 – **INVENTORY SURVEY**

The Santa Cruz County Department of Agriculture, in partnership with Monterey, San Benito and Santa Clara Counties, are hosting a no-cost **Pesticide Disposal Event in 2026**. The event is for you to legally relinquish any unwanted pesticides, including banned and legacy pesticides, in your possession. We will receive these pesticides at no cost for agricultural producers, non-production agriculture operations, such as golf courses, parks, and cemeteries, and pest control businesses, who are permitted with their respective counties. Your participation requires evaluating and pre-reporting all of your pesticides for disposal, as well as transportation of those pesticides to the event location. Location will be in North Monterey County close to Hwy 101.

No regulatory action will be pursued because of your participation.

This is to announce the FINAL survey if you would like to participate in this event, please complete the survey with a COMPLETE DETAILED LIST OF ALL PESTICIDES you want to bring to the disposal event.

This detailed survey is required to RECEIVE AN APPOINTMENT TIME for the event.

Please note:

- No single container over 50 lb. or 5 gallons will be accepted.
- Pesticides containing dioxins or mercury will not be accepted
- Unknown white or black powders will not be accepted; they may be explosive
